



NOTICE OF RACE

470 CLASS EUROPEAN CHAMPIONSHIP 9 - 17 MAY 2025

J.K. Mornar, in co-operation with the International 470 Class Association and under the auspices of the Croatian Sailing Federation, are pleased to invite 470 sailors to take part in the:

2025 Mixed 470 European Championship

(for mixed crews)

in Split, Croatia from 9 – 17 May 2025

1. RULES

- 1.1 The Championship will be governed by the rules as defined in *Racing Rules of Sailing* (RRS). Other documents under RRS Definition Rule (g) include
 - 1.1.1 The standard 470 Event Measurement Regulations & Policies.
 - 1.1.2 The standard 470 Athlete Media Regulations.
- 1.2 No National Authority prescriptions will apply.
- 1.3 For the Medal Races, World Sailing Appendix MR, Umpired Medal Racing, currently available on the World Sailing website shall apply. The version that is current when the regatta begins will be listed in the Sailing Instructions.
- 1.4 No Class Rule variations will apply.
- 1.5 In all rules governing this Championship:
- 1.5.1 [NP] denotes a rule that shall not be grounds for protests by a boat. This changes RRS 60.1.







- 1.5.2 [SP] denotes a rule which a standard penalty may be applied by the Race Committee without a hearing, or a discretionary penalty applied by the International Jury with a hearing. This changes RRS A5.
- 1.6 If a boat is to produce a measurement certificate, she shall do so before 19:00 local time on 11 May 2025. This changes RR 78.2.
- 1.7 If there is a conflict between languages the English text will take precedence.

2. [SP] [NP] ADVERTISING AND BOW NUMBERS

- 2.1 [SP] Boats may be required to display bow numbers and / or advertising chosen and supplied by the Organizing Authority. If this rule is broken, World Sailing Regulation 20.9.2 applies.
- 2.2 From the second racing day, competitors ranking first second and third in the series at the beginning of each day shall wear on top of their clothing yellow, blue and red bibs respectively while racing that day. The bibs will be provided by the Organizing Authority.
- 2.3 [SP] Boats are required to display national flags on their mainsail as in class rule C.10.4(a)(4). 470/World Sailing approved national flag manufacturers can be found at:

3. ELIGIBILITY AND ENTRY

3.1 The regatta is open to boats of the 470 Class and to competitors who comply with World Sailing Regulation 19 – Eligibility Code. On 1 March 2022, World Sailing published the following recommendations in reaction to the situation in Ukraine: https://www.sailing.org/2022/03/01/world-sailing-statement-6/. To help preserve the integrity and safety of the 2024 470 European Championships, entries shall be open to competitors of all nationalities, but not to competitors holding only Russian or Belarusian nationality.

Participating crews in the regatta shall be approved by their National 470 Class Association. Only crews representing nations in good standing with the International 470 Class Association may participate. Each crew member shall be member of a National 470 Class Association affiliated to the National Authority or an individual member of the International 470 Class Association when there is no National Association in the concerned country.

The European Championship is open to all nations, but only crews from European nations as defined by World Sailing may compete for the European Champion title.

3.2 Eligible teams shall fill in the relevant "On-line Entry Form" on the Championship website of the International 470 Class Association at 2025europeans.470.org. A request for entry becomes a valid pre-entry when the relevant National 470 Class Association, or the National Authority where there is no National Association, has confirmed to the International 470 Class Association that the corresponding crew is approved to take part in the Championship and meets the eligibility criteria, and when the International 470 Class Association has received the payment of the entry fees. The International 470 Class Association will publish the list of pre-entries on its website. Only crews with valid pre-entry in the list may take part in the Championship.







- 3.3 Entries must be sent and entry fees shall be paid to the International 470 Class Association on or before 11 April 2025 to benefit from the advantage of the reduced entry fees (refer to 4.2).
- 3.4 Entries sent after the deadline indicated above, but on or before 2 May 2025, will be accepted with the required entry fees (refer to 4.1). Late entries received on 3 May 2025 or later will be accepted only at the discretion of the Management Committee of the International 470 Class Association, whose decision shall be final.
- 3.5 Competitors under 18 years of age shall present a signed and completed parent (or guardian) consent and declaration form at on-site registration. They may choose to download their Entry Form from their Sailor Account once you have completed your entry and entry fee payment to the Championship.
- 3.6 Support Team members (Coaches, team leaders and representatives from participating nations) are requested to fill in the entry form posted at 2025europeans.470.org on or before 5 May 2025. Late entries received on 6 May 2025 or later will be accepted only at the discretion of the Organizing Authority, whose decision shall be final. Entry fees shall be paid direct to the Organizing Authority during on-site registration (refer to 4.3).

4. FEES

- 4.1 The entry fee is EUR555 per boat.
- 4.2 The entry fee is reduced to EUR455 per boat for boats that have completed online entry and paid their entry fee on or before 11 April 2025.
- 4.3 Entry fees to be paid by Support Teams are EUR100 per person and **shall be paid directly to the Organizing Authority at on-site registration**. The Support Team entry fee is reduced to EUR75 for persons that will complete their online entry on or before 5 May 2024.

These entry fees include all collective services provided by the Organizing Authority, such as social events, boat park facilities, toilets and showers.

5. CHAMPIONSHIP FORMAT

5.1 Each event shall consist of an opening series and a medal race, provided a minimum of 5 races have been completed in the opening series. The opening series may be divided into a qualifying series and a final series. The top ten finishers in the opening series shall advance to the Medal Race.







- 5.2 Opening series:
- 5.2.1 Qualifying series 5 races are scheduled. Crews will be divided into fleets. Each fleet will have approximately the same number of boats.
- 5.2.2 The number of fleets will be as defined below:
 - one fleet up to 40 boats,
 - two fleets from 41 to 80 boats,
 - three fleets for more than 80 boats.

The number of fleets as above may be changed by the Organizing Authority with the approval of the International 470 Class representative, when the total number of entries is close to the limits stated in this NoR.

- 5.2.3 <u>Final series</u> 6 races are scheduled. Crews in the qualifying series will be divided into final fleets according to the final scores of the qualifying series. There will be the same number of fleets as in the qualifying series. Each fleet will have approximately the same number of crews. The Gold fleet shall consist of the first part of the final scores of the qualifying series, Silver fleet of the second part, and so on.
- 5.2.4 <u>Single series</u> If there are fewer than 40 entries then the Championship will be competed in one fleet with 11 races in the opening series and a Medal Race, provided a minimum of 5 races have been completed in the opening series.
- 5.3 Medal Race will be scheduled as per NoR 5.1.

6. SCHEDULE

6.1 Schedule of races:

- 6.2 No warning signal will be given after 16:30 on the last racing day.
- 6.3 No more than three races shall be sailed each day.

7. [SPI [NPI MEASUREMENT

- 7.1 A Technical Committee shall be appointed in accordance with RRS 92.
- 7.2 Each boat shall produce a valid Measurement Certificate, including the completed Measurement Form, at the time of pre-race equipment inspections. If the completed







Measurement Form is a photocopy, its authenticity shall be confirmed with an original stamp and signature from the issuing authority.

- 7.3 Pre-race equipment inspections will consist of full measurement of all boats.
- 7.4 The current Event Measurement Regulations and Policies will be published on the Championship website before the start of the event and posted on the official notice board the day before the first day for event measurement. They will be available to competitors, team leaders and coaches at the Race Office upon request.
- 7.5 In accordance with RRS78, competitors are responsible for maintaining their boat in accordance with the Class Rules. For the purpose of RRS 78, competitors are considered to be the owners. Equipment checks may be performed at random during the regatta.

8. SAILING INSTRUCTIONS

Sailing Instructions will be available during registration at the Race Office and at the Championship website. Other documents governing the event will be published with the Sailing Instructions.

10. COURSES

The courses will be Windward/Leeward or Trapezoid.

11. PENALTY SYSTEM & INTERNATIONAL JURY

- 11.1 RRS Appendix P, Special Procedures for RRS 42, will apply.
- 11.2. RRS P2.3 will not apply and RRS P2.2 is changed so that it will apply to any penalty after the first one.
- 11.3 An International Jury shall be appointed in accordance with RRS 91(b).
- 11.4 Decisions of the International Jury shall be final as provided in RRS 70.3.

12. SCORING

- 12.1 RRS Appendix A will apply.
- 12.2 Qualifying series:
 - There will be a minimum of 4 and a maximum of 5 races in the qualifying series.
 - When there are 4 completed qualifying races at the end of a racing day, then the event will proceed on the next racing day with the Final series.
 - All race scores from the qualifying series will be carried forward to the final series.







12.3 Final series:

- There will be 6 races in the final series.
- At least 1 final race for the Gold fleet is required to be completed to constitute the Championship for all fleets and/or to enter the Medal Race.

12.4 Single series

- There will be 11 final races in the single series.
- At least 5 final races are required to be completed to constitute the Championship or to enter the Medal Race.

12.5 Discards

- When fewer than 3 races have been completed, a boat's series score is the total of her race scores from all races,
- When 3 or more races have been completed, a boat's series score is the total of her race scores excluding her worst score.

12.6 Medal Race

- The boats assigned to compete in the Medal Race will be ranked highest in the Championship except for a boat disqualified from the Medal Race under RRS 6 or 69.
- A boat's score shall be double the number of points specified in RRS Appendix A4, and the score of that race shall not be excluded from the series score.
- Ties in the series score between boats with different Medal Race point scores shall be broken in favour of the boat that scored better in the Medal Race. This changes RRS Appendix A8.

13. [SP] [NP] SUPPORT TEAMS

- 13.1 All Support Team members shall be registered (see 3.5) with the Organizing Authority and will be required to comply with local legislation and event Support Team Regulations. The Organizing Authority may refuse registrations and accept later registrations at their sole discretion.
- 13.2 Registered Support Team boats shall:
 - a) fly a flag with their three letter national code (see RRS G1.1) clearly displayed, or shall carry a sticker of their three letter national code on each side of the boat or engine. The minimum height for the letters shall be 200 mm. The flag or stickers will not be provided by the Organizing Authority.
 - b) fly a numbered identifier flag which will be provided by the Organizing Authority during registration. A deposit of EUR 10 will be required in order to receive the flag, which will be reimbursed upon return of the flag at the end of the event.
- 13.3 Registered support boats shall act as assistance / rescue boats in case of need and shall comply with any instructions given by the Race Committee or the Organizing Authority.
- 13.4 All support boats shall have third party liability insurance with a minimum cover of EUR 1.500.000 or equivalent per incident.

14. [SP] [NP] BERTHING

When berthed, boats shall be kept in their assigned place at the boat park.







15. PRIZES AND TITLES

15.1 The first European crew of the final official ranking list of the European Championship will be declared:

"470 Class Mixed European Champion"

- 15.2 The first crew of the final official ranking list will be awarded the "**470 Kevin Burnham Trophy**" by the International 470 Class Association.
- 15.3 Medals will be awarded to the first, second and third place crews of the European Championship by the International 470 Class Association.
- 15.4 Prizes will be awarded to the top-ten placed crews of the European Championship by the Organizing Authority.
- 15.5 The medals and prizes are given to both crew members.

16. RISK STATEMENT

- 16.1 Competitors and support team members participate in the Championship entirely at their own risk and they are reminded of the provisions of RRS 3, Decision to Race. Sailing is by its nature an unpredictable sport and therefore involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:
- 16.1.1 They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- 16.1.2 They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- 16.1.3 They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- 16.1.4 By participating in any race, they are satisfied that their boat is in good order, equipped to sail in the event and they are fit to participate;
- 16.1.5 The provision of a race management team, safety boats, judges and other officials and volunteers by the organizer does not relieve them of their own responsibilities;
- 16.1.6 The provision of safety boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.
- 16.1.7 They will familiarize themselves with any venue/event specific risks, adhere to rules and information produced for the venue/event and they will attend any venue/event safety briefings.
- 16.2 The Organising Authority and all parties involved in the regatta organisation will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

17. [SP] [NP] MEDIA RIGHTS, CAMERAS AND ELECTRONIC EQUIPMENT

17.1 By participating in the Championship, competitors automatically grant to the International 470 Class Association and to the Organizing Authority and their sponsors, the right in perpetuity to make, use and show, from time to time at their discretion, any motion pictures and live, taped or filmed television and other reproductions of the athlete during the period of the competition without compensation.







17.2 Boats may be required to carry cameras, sound equipment or positioning equipment as specified by the organizing authority and in accordance with Class Rule C.5.1 (a) (3).

18. INSURANCE

Each participating boat shall be insured with valid third party liability insurance with a minimum cover of EUR 1,500,000 per event or equivalent. The Organizing Authority will not be responsible for verifying the status or validity of such certificates.

19. [SP] [NP] ENVIRONMENTAL RESPONSIBILITY

Participants are encouraged to minimize any adverse environmental impact of the sport of sailing. It is recommended that care be taken to protect the environment at all times during and after the event. Special attention is drawn to RRS 47 -TRASH DISPOSAL- which states: "Competitors and support persons shall not intentionally put trash in the water. This rule applies at all times while afloat. The penalty for a breach of this rule may be less than disqualification".

20. AMENDMENTS TO THE NOTICE OF RACE
